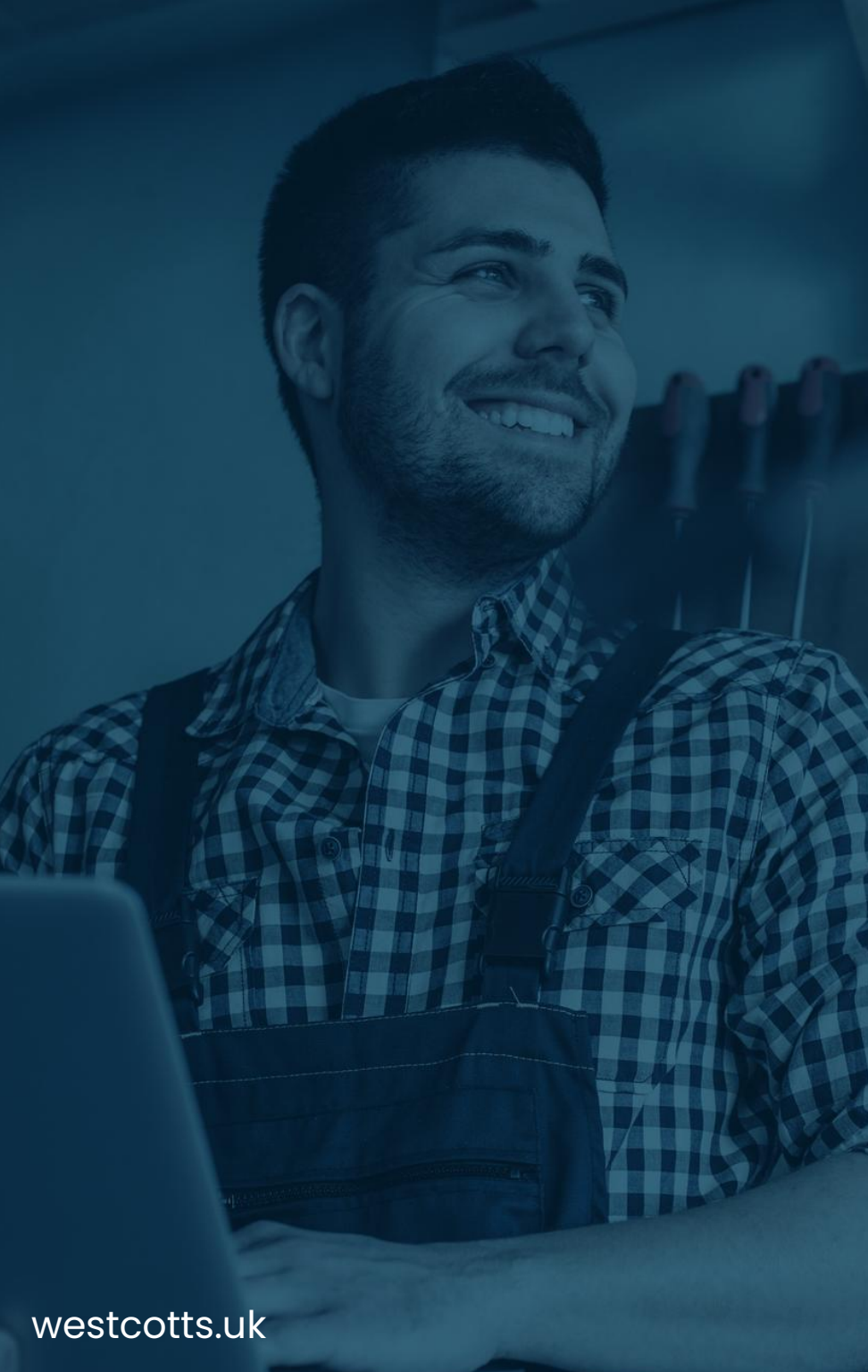

5 Commonly Overlooked Business Expenses...





Staff events

You can spend up to £150 per employee on social events annually.

Under £150 is it not a taxable benefit for your employee but if you go 1p over the whole amount becomes a taxable benefit.



Trivial gifts

Remember that you can give to your employees a gift of up to £50 (including VAT).

As long as: the gift is not cash (or a voucher that can be converted into cash), not a reward for service and not expected as part of a contract.

If you go over £50 then this becomes a taxable benefit to the employee.

Charitable donations

You can get tax relief for a donation to a registered national charity.



Mileage

If you use your private vehicle for business journeys, you can claim back 45p/mile from your company. Don't forget – you can also claim an additional 5p/mile on top if you have a passenger, and you can claim 20p/mile if you use your own bicycle.

Directors and employees can claim tax relief for 'use of home as office' of £312 per year (HM Revenue & Customs published rate).
